OUR ACHIEVEMENTS

Over the years PIPA has achieved major gains for the plastics pipe industry:

- Reducing deselection and promoting the benefits of plastic pipeline systems to specifiers, designers and major stakeholder groups.
- The removal of the PVC minimisation clause to the Green Star rating tool and an introduction of an option where the use of Best Environment Practice PVC pipe is encouraged.
- Being instrumental in the development of the APGA Coal Seam Gas Code of Practice for the installation of PE pipe systems in this rapidly expanding industry ensuring PE is the material of choice for this application.
- Ensuring plastic pipe systems achieve the best possible outcomes through development of standards and publication of industry leading technical documentation referenced by standards and key industry stakeholders.
